

# 2019 Innovation Showdown Application Question List

Use this list as a guide to gather all of the information needed prior to submitting your application.

The Innovation Showdown is a collaborative project bringing the nation's top animal welfare organizations together to invest in lifesaving innovation.

U.S. based nonprofit or municipal animal welfare organizations with a primary mission of saving companion animals (including community cats) and for-profit entities with a primary purpose of saving animal lives are encouraged to apply. Pitches must come from an authorized representative of the organization or company. Any investment to a for-profit company will be restricted for use applied to the animal welfare lifesaving idea.

This year's Showdown will be presented at the HSUS Expo in New Orleans, April 15-18th. Innovation Showdown participants seeking funding to save lives will present their innovative animal welfare ideas on stage to the Innovation Investors.

Eligible organizations may submit up to two Innovation Ideas for consideration in the 2019 Innovation Showdown. Finalists and submitters from last year are encouraged to submit their ideas again with an improved pitch.

Please note: You may not save and return to the application later so applicants are encouraged to prepare their answers before beginning an application. Only begin the application when you are able to fully complete it.

Deadline to apply is 5 PM CST Tuesday, January 15.

All finalists will need to be available between March and April to work with us on an event video and their pitch. They must also be able to attend Animal Care Expo April 15-18. All travel expenses for two organization representatives will be paid by the Petco Foundation and conference registration will be covered courtesy of HSUS.

The Innovation Showdown is open to nonprofit organizations and for-profit companies. Pitches must come from an authorized representative of the organization or company. Any investment to a for-profit company will be restricted for use applied to the animal welfare lifesaving idea.

Organizations can submit up to 2 ideas but only one can be selected as a finalist.

U.S. based nonprofit or municipal animal welfare organizations with a primary mission of saving companion animals (including community cats) and for-profit entities with a primary purpose of saving animal lives are encouraged to apply.
