**OFFICIAL RULES**

VOTING OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, AND PUERTO RICO WITH VALID EMAIL ADDRESSES. NO PURCHASE OR PAYMENT NECESSARY TO VOTE. A PURCHASE WILL NOT INCREASE CHANCES OF WINNING. MUST BE IN THE UNITED STATES OR PUERTO RICO TO VOTE.

**1. ELIGIBILITY:** Voting is open only to legal residents of the 50 United States, the District of Columbia and Puerto Rico with valid email addresses. Void where prohibited.

**2. PROMOTION PERIOD:** The Unsung Hero People's Choice Voting Campaign ("Campaign") begins at Noon Central Time ("CT") on May 1, 2020 and ends at Noon CT on May 15, 2020. Petco Foundation reserves the right to extend the voting period.

**3. TO VOTE:** To vote, visit [www.Petcofoundation.org/unsunghero](http://www.Petcofoundation.org/unsunghero) ("Web Site") during the Promotion Period and access the Wishpond voting platform. Complete the entry form and submit as directed. Votes must be received by Noon CT on May 15, 2020. Web Site's server is the official clock for this contest. By voting, you have the option to opt-in to receiving promotional emails from the Petco Foundation. You may opt out of receiving these emails at any time after receiving the first email.

**4. LIMIT ONE VOTE PER ENTRY.** Voters may not vote more than permitted by using multiple/different email addresses, identities or other methods. Any voter who enters more than once or uses any device or artifice to circumvent these Official Rules may be disqualified and have their votes void.

**5. ENTRY WITH THE MOST VOTES:** The entry with the most verified votes will be recognized as the Petco Foundation's National Unsung Hero Award recipient and their organization will be eligible to receive a \$50,000 grant.

**6. GENERAL:** By participating, voters agree (a) to these rules and decisions of judges which shall be final in all respects; (b) to release and hold harmless the Petco Foundation and each of their respective subsidiaries, affiliates and agencies, and their respective directors, officers, employees, agents and representatives (the "Releasees") from any and all claims, demands, costs, expenses, liability, losses or damages of any kind resulting from their participation in the promotion or their acceptance, use or misuse of a prize, including liability for personal injury or death. 2. I represent and warrant, on my own behalf, that I have not voted more than permitted by using multiple/different email addresses, identities or other methods. Any voter who enters more than once or uses any device or artifice to circumvent these Official Rules may be disqualified and have their votes void.
3. Offering incentives for voting, paying for votes or voting on behalf of another person is not permitted.
4. The Petco Foundation reserves the right to remove fraudulent votes and disqualify organizations from the Unsung Heroes People's Choice voting.
5. I acknowledge that I must provide my email address to participate in the gallery poll.

**8. PRIVACY:** Information submitted in connection with this promotion will be treated in accordance with these Official Rules located at site [www.petcofoundation.org/unsunghero](http://www.petcofoundation.org/unsunghero) and Petco's Privacy Policy (as may be amended from time to time), currently located at <https://www.petco.com/privacy-policy>

provided, that in the event of any conflict between these Official Rules and such Privacy Policy, the terms and conditions of these Official Rules shall prevail.

**9. ARBITRATION/CHOICE OF LAW:** Except where prohibited, voters (and voter's parent/legal guardian if voter is a minor) agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Campaign, or any prize awarded, or the determination of the winners, shall be resolved individually, without resort to any form of class action, and exclusively by arbitration pursuant to the Rules of the American Arbitration Association, then effective, and (2) any and all claims,
